

LARCENY® KEY IN ON ICE CONTEST  
2024 OFFICIAL RULES

**NO PURCHASE OR PAYMENT NECESSARY TO WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. NO CONSUMPTION OF ALCOHOL IS REQUIRED TO PARTICIPATE.**

- 1) ELIGIBILITY:** The LARCENY® KEY IN ON ICE CONTEST (“Promotion”) is open only to legal residents of the United States and excluding AK, HI, MD, PR, OR, RI, and VT, who are (a) 21 years of age or older at the time of entry; and (b) registered users of [www.instagram.com](http://www.instagram.com), and/or [www.facebook.com](http://www.facebook.com) (as applicable) with an active, public (if applicable) account from the time of entry until the end of the Promotion Period (defined below). Employees, directors, agents and officers of Sponsor, participating vendors (if any), alcohol beverage retailers, alcohol beverage distributors, their respective parent companies, affiliates, and subsidiaries, and their respective participating advertising, promotions, and public relations agencies as well as members of their immediate families and/or those living in the same household as such individuals are not eligible to enter. The Promotion is (a) governed by these Official Rules, (b) void where prohibited or restricted by law, and (c) subject to all applicable federal, state, and local laws and regulations. Once participant finds the code, the code will be submitted at [LarcenyBourbon.com/key-in-on-ice](https://larcenybourbon.com/key-in-on-ice) (the “Contest Website”). The first five (5) entrants who submit the correct code will be selected to win Prizes in accordance with these Official Rules. The Promotion is subject to entry period dates and times as outlined in the “ENTRY PERIODS” section below. For purposes of these Official Rules, all times are given in ET.

- 4) HOW TO ENTER:** There is one way to enter:

Each entrant should visit the Contest Website ([LarcenyBourbon.com/key-in-on-ice](https://larcenybourbon.com/key-in-on-ice)), Sponsor’s Instagram Page (<https://www.instagram.com/larcenybourbon/>), Sponsor’s affiliated social media influencer’s Instagram account, or Sponsor’s Facebook Page (<https://www.facebook.com/LarcenyBourbon>), for a weekly post during

the Promotion Period, which will contain a clue that directs the entrant to the location of the code that could be found in one of the following places: (1) Sponsor's Main Website (<https://larcenybourbon.com>); (2) Sponsor's Instagram Page (<https://www.instagram.com/larcenybourbon/>); (3) Sponsor's Facebook Page (<https://www.facebook.com/LarcenyBourbon>), or (4) Sponsor's affiliated social media influencer's Instagram account (which will be identified on Sponsor's Instagram). Once the entrant has located the potential code, the entrant will submit the code on the entry form and complete all the necessary information included on such form located on the Contest Website. The first five (5) entrants of each Entry Period who submit the correct code will be selected to win a Prize in accordance with these Official Rules.

  - c) Submissions that contain any viruses, spyware, malware or other malicious components that are designed to harm the functionality of a computer in any way may not be submitted and may be disqualified at any time in Sponsor's sole and unfettered discretion.

Sponsor reserves the right in its sole and unfettered discretion to disqualify any Submission that it believes violates or potentially violates any of the foregoing requirements or otherwise fails to comply with any

provision of these Official Rules. The decisions of the Sponsor on this and all matters pertaining to the Promotion shall be final and binding.

- 7) **INTELLECTUAL PROPERTY:** The intellectual rights to the Submission, if any, will remain with the entrant, except that these Official Rules do not supersede any other assignment or grant of rights according to any other separate agreements between entrants and other parties. As a condition of entry, entrant agrees that Sponsor shall have the right to use, copy, modify and make available the Submission in connection with the operation, conduct, administration, and advertising and promotion of the Promotion and of Sponsor via communication to the public, including, but not limited to the right to make screenshots, animations, and video clips available to the public for promotional and publicity purposes. Such notification will request and require Winner to provide all necessary information to redeem the prize (such as first and last name, email address, mailing address, and/or phone number) to Sponsor. All winners are subject to verification of eligibility and compliance with these Official Rules. Decisions of Sponsor and Judges are final and binding. - 12) **WARRANTY AND INDEMNITY:** Each entrant represents and warrants that their Submission is original, that they are the sole and exclusive owner and right holder of the submitted Submission, and that they have the right to submit the Submission in the Promotion. Each entrant further represents and warrants that their Submission does not (1) infringe any third-party proprietary, intellectual property, industrial property, personal rights or other rights, including without limitation, copyright, trademark, patent, trade secret or confidentiality obligation; (2) include any personally identifiable information of any person other than entrant; or (3) otherwise violate any applicable law. To the maximum extent permitted by law, each entrant indemnifies and agrees to keep indemnified the Released Parties at all times from and against any liability, actions, claims, demands, losses, damages, costs and expenses for or in respect of which the Released Parties may become liable by reason of or related or incidental to any act, default or omission by an entrant under these Official Rules including without limitation resulting from or in relation to any breach, non-observance, act or omission, whether negligent or otherwise, of these Official Rules by an entrant.
- 13) **ELIMINATION:** Any false information provided within the context of the Promotion by any entrant concerning identity, postal address, telephone number, ownership of right or noncompliance with these Official Rules or the like may result in the immediate elimination of the entrant from the Promotion. Sponsor further reserves the right to disqualify any Submission that it believes in its sole and unfettered discretion infringes upon or violates the rights of any third party or otherwise does not comply with these Official Rules.
- 14) **WAIVER:** Entrants hereby waive all rights to: (i) claim punitive, exemplary, special, incidental, indirect and consequential damages and any other damages (whether due to negligence or otherwise), other than for actual out-of-pocket costs; and (ii) have damages multiplied or otherwise increased.
- 15) **LIMIT OF LIABILITY:** Sponsor is not responsible for electronic transmission errors resulting in omission, interruption, deletion, defect, delay in operations or transmission, theft or destruction or unauthorized access to or alterations of entry materials, or for technical, network, telephone equipment, electronic computer,

hardware or software malfunctions or limitations of any kind, or inaccurate transmissions of or failure to receive entry or Submission information by Sponsor on account of technical problems or traffic congestion via mobile phone or otherwise. If, for any reason, the Promotion is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, act of God, or any other causes which corrupt or otherwise affect the administration, security, fairness, integrity, or proper conduct of this Promotion, Sponsor reserves the right at its sole discretion to cancel, terminate, modify or suspend the Promotion or any portion thereof at any time, and for any reason without further obligation or advance notice. Sponsor reserves the right, but does not have any obligation, to select winners from eligible entries received as of the termination date. Sponsor further reserves the right to disqualify any individual who tampers with the entry process or the operation of the Promotion or acts in violation of these Official Rules or in an unsportsmanlike or disruptive manner.
